

## Joint MLA/AAHSL Legislative Task Force

### 2009 Annual Report

The Joint Legislative Task Force supports advocacy efforts of AAHSL and MLA and consists of membership from both organizations. Ex-officio members from AAHSL who serve during their appointed AAHSL terms include the current president and chair of the Scholarly Communications Committee. The position of chair rotates between the two organizations every two years. Michael Homan served as vice-chair from November 2008 to November 2009 and will continue as vice-chair until 2010. Hope Barton from MLA currently serves as chair. Key Washington support for this joint program is provided by the Health and Medicine Council of Washington (HMCW) funded by both organizations and by MLA Legislative Staff Liaison, Mary Langman. The task force normally meets biannually in Washington, DC to conduct business and to meet with members of Congress or their staff according to schedules prepared by HMCW.

### Meetings

#### Spring Task Force Meeting: March 23-24, 2009

- Reports were presented by Betsy Humphreys, Deputy Director, NLM; Jerry Sheehan, Assistant Director for Policy Development, NLM; Elaine Rubin, Vice President Policy and Program, Association of Academic Health Centers; Dale Dirks, President, Health and Medicine Counsel of Washington.
- The task force approved establishing a working group of MLA and AAHSL members to develop a health care reform statement, building upon the 1993 joint MLA/AAHSL Statement: *Health Care Reform and the Health Sciences Librarian*.
- Four teams of task force members visited Congressional offices to address issues of FY 2010 NLM funding, continued support for the NIH Public Access Policy, and healthcare reform.

#### Fall Task Force Meeting:

A fall Task Force meeting was not scheduled due to budgetary considerations. A virtual meeting will be scheduled for the first quarter of 2010, and the - spring 2010 meeting will occur in conjunction with the Washington MLA Annual Meeting in May. An attempt to visit with key staff of the new Academic Medicine Caucus in the House of Representatives will be scheduled for the May 2010 Task Force meeting.
