Summary of NIH Public Access Mandate Mini-Survey Project 2008 and 2009 Surveys of AAHSL Members

In June of 2008 and again in June of 2009, the Schol Com NIH P/A Mini-Survey Task Force surveyed the AAHSL Membership about institutional responses to the NIH Public Access Mandate that became law in April of 2008. 59 responses were received in 2008, and 53 in 2009. Members of the task force are noted on the last page of this report. A summary of the responses is posted on the AAHSL site. This report compares the responses to these two surveys.

New data from the 2009 survey include ranking the effectiveness of methods used to promote compliance and information about the effect of this mandate on institutional repositories. Notable in both surveys is the lead role libraries continue to play in supporting, publicizing, and helping guide institutions towards compliance.

The 2009 survey again demonstrates that communication with and guidance for faculty around scholarly publishing is a growing role for libraries. 68% of respondents noted an increase in Schol Com communication this past year. This does not need to be limited to the NIH/PA mandate, and many libraries continue to use the mandate as an opportunity to have important discussions with researchers, authors, and administrators.

Comments on IR

Increased submissions not related to NIH PA Mandate

IR in soft rollout mode -- will be more widely promoted this Fall.

We may participate in digital repository efforts with CTSA, Educational Technology, or University Library Digital efforts. No overall IR.

Yale has established an Office of Digital Assets and Infrastructure which will start working on an IR. Library has a rep on this committee.

General comments on survey or NIH P/A Mandate

Survey addresses only depositing manuscripts into PMC. Citing articles in PMC in NIH progress reports etc a growing library service.

Regarding Q13 - reduced our print bound volumes

We are much more engaged in the mandate than the survey questions would indicate.

I think this is important information to track since the mandate is still under threat.

Much fanfare when mandate began, but role now less. Impressed with support from NIH & NLM.
